1 INTRODUCTION

Islamic Relief South Africa

Islamic Relief South Africa (IRSA) is an international humanitarian and development company. It was registered as a Section 21 non-profit company in 2004.

Water, hygiene and sanitation are critical elements of human survival. Fresh water in good quality and sufficient amount is essential for all aspects of human life and sustainable development. The fundamental human rights to water are recognized by states and it is the mandate of governments to provide safe drinking water to its citizens. Water plays a pivotal role in all aspects of development including food security, health and poverty reduction in sustaining growth in agriculture and maintaining health ecosystems.

Unfortunately, the right to water is neither universally nor equitably enjoyed. Different communities and schools have a disproportionate access to basic services. Learners in public schools and residents in rural communities still face unacceptable challenges to accessing water and sanitation services.

Background to Borehole Intervention

IRSA has been at the forefront in providing safe and clean drinking water in water-distressed communities around the world. In 2018, IRSA in partnership with its donors and the Muslim Community embarked on installing boreholes in water distressed communities as a contribution to solving the water scarcity problem encountered by communities and schools.

IRSA installed 18 boreholes all over the KwaZulu-Natal region. Throughout the past few years, the boreholes have deteriorated due to vandalism and theft that has taken place.

2 OBJECTIVE OF THIS REQUEST FOR PROPOSAL (RFP)

The purpose of this Request for Proposal (RFP) is to invite suitable, qualified and competent service providers to submit proposals to be considered for inclusion as the preferred service provider

This RFP document details and incorporates, as far as possible, the tasks and responsibilities of the potential bidders required by IRSA for the rehabilitation and servicing of 19 boreholes in the KwaZulu-Natal region.

This RFP does not constitute an offer to do business with Islamic Relief South Africa, but merely serves as an invitation to bidder(s) to facilitate a requirements-based decision process.

The RFP is based on the Technical Assessment Reports that have been provided by Islamic Relief South Africa.

12.1 IRSA reserves the right to conduct supplier due diligence prior to final award and at any time during the contract period. This may include but is not limited to conducting site visits at the bidder's corporate offices and requests for additional information.

12.2 The bidder is responsible for its own due diligence investigation in connection with the Service and all matters relating to this RFP. Neither IRSA nor any of its officers, employees, agents or advisers make any representation or warranty, express or implied, concerning any matter affecting the Service, other than the representations and undertakings of IRSA set out in the Service Agreement.

12.3 The service provider shall, with due care and diligence, execute and maintain the works and provide all labor, materials, equipment, transportation, and other facilities necessary to substantially complete the works by the planned completion date, and in accordance with the requirements, documents and the standards defined by it.

12.4 The service provider shall take full responsibility for the adequacy, stability, and safety of all site operations and for the security of the site itself, including the security of all materials stored or used on the site.

13 BID RULES

13.1 IRSA reserves the right to interview bidder(s) that would have been short listed.

13.2 The Bidder(s) may not cede or assign any part of its agreement with IRSA nor subcontract any part of the work assigned to them without the prior written authorisation of IRSA.

13.3 Failure to comply with any conditions of this request for a proposal will invalidate this tender proposal.

13.4 Regular bi-weekly written feedback must be given to the Project Manager, or his/her nominee on all matters received from IRSA with the service provider, at no costs to the IRSA.

13.5 Payment of service by IRSA will be effected within 30 (thirty) days from date of receipt of an acceptable invoice.

IRSA reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process.

16 DURATION OF THE CONTRACT

The project is to start and end as per the date agreed on the Service Level Agreement (tentatively December). The project shall be under the control of the designated representative(s) appointed by Islamic Relief South Africa. The designated representative(s) shall appoint one or more technical supervisors who shall be responsible for the management and direction of the project on-site and shall approve all supplied materials, works, and measurements carried out by the bidder and his team of workers on the project.

17 SCOPE OF WORK

17.1 General Scope of Work

17.1.1 Yield test – The service provider should conduct a yield test to determine whether there is still sufficient water underground or not since the boreholes were installed in 2017/2018.

17.1.2 **NB: The minimum borehole yield should be 2500 liters/hour before rehabilitation of a borehole can be considered. The successful bidder will submit the yield test to the appointed IRSA official.**

17.1.3 Rehabilitate borehole – If the yield test shows positive results as per above minimum water yield, the service provider, with permission from the IRSA appointed official, will rehabilitate the borehole according to the Technical Assessments provided.

17.1.4 Geohydrological Survey – If the yield test shows negative results of sufficient water, the service provider should conduct a Geohydrological survey to determine where, within that region, they can find water.

17.1.5 The company will cover the supply of all materials and equipment required for the rehabilitation of the boreholes. The rehabilitation of the boreholes are to be equipped with quality SABS-approved pumps, plumbing pipes and fittings and electrical fittings with a minimum guarantee of 12 months.

17.1.6 The Company/Consultant shall conduct the rehabilitation of the borehole taking into consideration the distance and the state of the roads to the different sites. Islamic Relief will not be responsible for any damage or loss to equipment or personnel in this undertaking. The Company/Consultant is expected to carry out all the work as stipulated in the scope of work in a workman manner and up to the current professional standards. For this purpose, the Company/Consultant shall use suitable machinery and gear, and efficient and experienced staff.

17.1.7 The Service provider shall be responsible for the rehabilitation of the boreholes according to the technical assessments provided (water quality testing, taps replacement, pump replacement etc.)

17.1.8 Rehabilitation & Servicing: Rehabilitation/servicing of the boreholes will be done as per the technical assessments and additional borehole features such as the following:

- Water Level measurement
 - Replacing electric pumps
 - Water Quality testing
 - Servicing electrical distribution boxes
 - Minor plumbing and changing fittings
 - Installation/Replacement of filters
 - Replacing worn-out electrical cables
 - Determine yield (liters per hour)
